## RULES & REGULATIONS

1. Harford Horse Shows Association (HHS) primary association of this show. Therefore, this show will be operated in accordance with the 2018 HHS Rulebook and the rules and regulations therein.
2. As per Maryland state requirements, ALL horses and ponies must present a negative Coggins, dated 12 months prior to show date, at the Show Office before any back number is issued.
3. ALL DOGS MUST BE LEASHED on the show grounds property.
4. All exhibitors must appear in proper riding attire. Any individual mounted on a horse or pony at any time on the show grounds must wear protective headgear that meets current ASTM-SEI standards, with the harness secured. Any rider violating this rule at any time must immediately be prohibited from further riding until their headgear is properly in place.
5. Show management reserves the right to make changes to the show schedule as needed if entries so warrant, including but not limited to: class locations, additions, cancellations, and combinations.
6. STALLIONS ARE BARRED from the show and show grounds.
7. Pony measurement cards must be presented in order to receive a back number. All ponies competing must have a current HHS, BCHS, MHS, VHS, or USEF measurement card. Ponies aged 6 years or younger must be measured each year. *If you are in need of measuring for your pony, please let the show office know.*
8. A completed release signed by an adult and form of payment must be left with the show office before any entry back number will be issued. Checks can be made out to Molly Hill Farm.
9. Three entries are needed to fill a performance class for full points to count toward year end award. A division may run with only two entries, but will warrant only half points.
10. All entries will be judged on soundness at the trot upon entering the ring. The decision of the ring's respective judge is final.
11. Molly Hill Farm, HHS, BCHS, and the MHF show staff will assume no responsibility, is not liable for any injury to any person or to any horse at any time, which includes going to, coming from, and in the ring. Neither will it be responsible for vehicles or articles that may be lost or damaged. All owners and exhibitors will be held responsible for any damage incurred by them or their agent's properties on the show grounds.
12. Cross entering divisions is permitted where eligible. Please refer to the 2018 HHS Rulebook for all division descriptions and respective regulations.
13. Schooling will be permitted in both rings until 7:45am. Restrictions may be imposed during schooling to ensure exhibitor safety at the discretion of show staff and show steward. Schooling prior to 7am is at own individual risk.
14. For show purposes, the age of an exhibitor will be determined as of December 1<sup>st</sup> 2017.
15. Six (6) ribbons will be awarded in each class. Champion & Reserve ribbons will be awarded for each division.
16. SMOKING IS NOT PERMITTED at any time while on the show grounds.
17. Barns, house, and all other structures are OFF LIMITS to visitors. Boarders & residents only please.

## DIRECTIONS

**DIRECTIONS FROM I-95:** Take Exit 80 (Belcamp) from I-95. Turn onto MD-543 NORTH (Creswell Rd). Follow MD-543 NORTH for 2 miles until you reach the first stoplight. Use the right lane to turn onto MD-136 NORTH (Calvary Rd). Follow MD-136 NORTH for approximately 13 miles. Turn left onto MD-646 (Prospect Rd). In 0.7 miles turn right onto Davis Corner Rd. In 0.5 miles, signs for Molly Hill Farm show parking will be on your right.

**DIRECTIONS FROM I-83:** Take Exit 20A (Cockeysville - Shawan Rd EAST) from I-83. Follow Shawan Rd for approximately 0.8 miles. Use the right hand lane to merge/turn right onto York Rd SOUTH. Follow York Rd until the next stoplight. At the stoplight, turn left onto MD-145 EAST (Ashland Rd). Follow MD-145 EAST (Ashland Rd turns into Paper Mill Rd) for approximately 5.5 miles. Turn left onto MD-146 NORTH (Jarrettsville Pike) and follow for approximately 7.5 miles. At the four-way stop, turn right onto MD-23 SOUTH (Norrisville Rd) and follow for approximately 2 miles. At the next stoplight with Keene Dodge car dealer on your left, use the left lane to turn left onto MD-165 NORTH (Federal Hill Rd). Take MD-165 NORTH for approximately 11.5 miles. Turn right onto MD-136 SOUTH (Whiteford Rd) and follow for approximately 3 miles. Pass by the Molly Hill Farm sign. Once past the sign and at the bottom of the hill, turn right onto MD-646 (Prospect Rd). In 0.7 miles turn right onto Davis Corner Rd. In 0.5 miles, signs for Molly Hill Farm show parking will be on your right.

## RELEASE & WAIVER OF LIABILITY

The Participant does hereby freely, voluntarily and without duress, executes this release under the following terms:

**1. WAIVER AND RELEASE.** Participant or Member do hereby release and forever discharge and hold harmless Molly Hill Farm, LLC and their respective directors, officers, employees, agents, successors and assigns from any and all actions, causes of action, suits, bills, claims, damages or demands of any nature whatsoever which Participant or Member may now have, ever had or hereafter may have, for, upon or by any reason of any matter, cause or thing whatsoever from the beginning of the world to the day of the date of these presents in any way relating to or growing out of which arise or may hereafter arise from Participant's attendance at and participation in the Event at the Venue. Participant or Member understand and acknowledge that this Release discharges Molly Hill Farm, LLC from any liability or claim that the Participant may have against Molly Hill Farm, LLC with respect to any bodily injury, personal injury, illness, death or property damage to Participant that may result from Participant's attendance at and participation in the Event at the Venue or from any Liability of claim that the Participant may have against Molly Hill Farm, LLC with respect of any bodily injury, illness or death to Horse that may result from Participant's participation in the Event at the Venue, whether caused by negligence of Molly Hill Farm, LLC or their respective officers, directors, employees, or agents or otherwise.

**2. MEDICAL TREATMENT.** Participant does hereby release and forever discharge Molly Hill Farm, LLC and their respective directors, officers, employees, agents, successors and assigns, from any claim whatsoever that arises or may hereafter arise on account of any first aid treatment or service rendered on connection with the Participant's participation in and attendance at or any veterinary treatment rendered to Horse or Pony in connection with the Horse or Pony's engagement in activities in the Event at the Venue.

**3. ASSUMPTION OF RISK.** The Participant acknowledges and agrees that participation in the Event sponsored by Molly Hill Farm, LLC at the Venue may include activities that may be hazardous to the Participant, including but not limited to, riding or walking in close proximity to Horses and Ponies. The Participant acknowledges and agrees that participation in the Event sponsored by Molly Hill Farm, LLC at the Venue may include activities that may be hazardous to the Horse/ Pony. In connection thereto, Participant or Member recognize and understand that attendance at and participation in the event sponsored by Molly Hill Farm, LLC at the Venue may, in some situations, involve inherently dangerous activities and environments. Participant or Member hereby expressly and specifically assumes the risk of injury or harm to Horse/ Pony arising from it's Participation in the Event and release Molly Hill Farm, LLC from all liability for injury, illness, death, property damage to Participant or Horse/ Pony resulting from the Participant's attendance at and/or participation in the Event sponsored by Molly Hill Farm, LLC at the Venue.

**4. OTHER.** Participant or Member expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Maryland, and that this release shall be governed by and interpreted on accordance with the laws of the State of Maryland. Participant or Member agree that in the event that any clause or provision of this release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
