All negative Coggins and waivers must be submitted at time of pre-entry. Incomplete and/or unsigned pre-entries will not be accepted.

RULES & REGULATIONS

1. This show is a bi-pointed show with Harford Horse Shows Association (HHSA) and Baltimore County Horse Show (BCHSA). HHSA is the presiding association, therefore this show will be run in accordance with the 2021 HHSA Rulebook, and the rules and regulations therein.
2. As per Maryland state requirements, ALL horses and ponies must present a negative Coggins, dated within 12 months of show date, at the Show Office before any back number is issued.
3. NO OUTSIDE DOGS ALLOWED on the show grounds property.
4. Proper riding attire is required. Any individual mounted on a horse or pony at any time on the show grounds must wear protective headgear that meets current ASTM-SEI standards, with the harness secured.
5. Show management reserves the right to make changes to the show schedule as needed, including but not limited to: class locations, additions, cancellations, and combinations.
6. STALLIONS ARE BARRED from the show and show grounds.
7. Pony measurement cards must be presented in order to receive a back number. All ponies competing must have a current HHSA, BCHSA, MHSA, VHSA, or USEF measurement card. Ponies aged 6 years or younger must be measured each year. If you are in need of measuring for your pony, please let the show office know.
8. A completed and signed release form (must be 18 or older to sign) and payment must be left with the show office before entry back number will be issued. Checks can be made out to Molly Hill Farm. Payment must be cash or check.
9. All entries will be judged on soundness at the trot upon entering the ring. The decision of the ring's respective judge is final.
10. Molly Hill Farm, HHSA, BCHSA, and the Molly Hill show management assumes no responsibility for any damage, accident, or injury which may occur to any horse, exhibitor, spectator, equipment, or vehicle at any time while on the show grounds.
11. Cross entering divisions is permitted where eligible. Please refer to the 2021 HHSA Rulebook for all division descriptions and respective regulations.
12. Schooling will be permitted in both rings until 7:45am. Restrictions may be imposed during schooling to ensure exhibitor safety at the discretion of show management and show steward. Schooling prior to 7am is at own individual risk.
13. A junior rider is anyone under 18 years of age as of December 1st of the previous year.
14. Six (6) ribbons will be awarded in each class. Champion and Reserve Champion ribbons will be awarded for each division.
15. SMOKING IS NOT PERMITTED at any time while on the show grounds.
16. Barns, house, and all other structures are OFF LIMITS to visitors. Boarders & residents only.

Cross Entry and Other Notes

BCHSA and HHSA have differing rules regarding riders cross-entering into other divisions or jump heights. They are noted below:

Beginner Rider Equitation riders may cross-enter into Mini or Short Stirrup for HHSA; but may not cross enter into any other division for BCHSA.

Long Stirrup Riders may cross enter into Novice for HHSA; but may only cross enter into LS Hunter for BCHSA.

Open Hunter – to earn points in Open Hunter, for BCHSA, the rider must show at the 3' height.

RELEASE & WAIVER OF LIABILITY

The Participant desires to attend and/or participate in an equestrian event sponsored by **Molly Hill Farm, LLC** to be held on **June 12, 2021** located at **Molly Hill Farm, 2022 Whiteford Road, Whiteford, Maryland 21160** ("Venue"), Participation in the equestrian event (the "Event") at the Venue includes, but is not limited to, the riding and or showing of a horse or pony owned, leased or otherwise by the Participant.

The Participant does hereby freely, voluntarily and without duress, executes this release under the following terms:

1. **WAIVER AND RELEASE.** Participant or Member do hereby release and forever discharge and hold harmless Molly Hill Farm, LLC and their respective directors, officers, employees, agents, successors and assigns from any and all actions, causes of action, suits, bills, claims, damages or demands of any nature whatsoever which Participant or Member may now have, ever had or hereafter may have, for, upon or by any reason of any matter, cause or thing whatsoever from the beginning of the world to the day of the date of these presents in any way relating to or growing out of which arise or may hereafter arise from Participant's attendance at and participation in the Event at the Venue. Participant or Member understand and acknowledge that this Release discharges Molly Hill Farm, LLC from any liability or claim that the Participant may have against Molly Hill Farm, LLC with respect to any bodily injury, personal injury, illness, death or property damage to Participant that may result from Participant's attendance at and participation in the Event at the Venue or from any Liability of claim that the Participant may have against Molly Hill Farm, LLC with respect to any bodily injury, illness or death to Horse that may result from Participant's participation in the Event at the Venue, whether caused by negligence of Molly Hill Farm, LLC or their respective officers, directors, employees, or agents or otherwise.

2. **MEDICAL TREATMENT.** Participant does hereby release and forever discharge Molly Hill Farm, LLC and their respective directors, officers, employees, agents, successors and assigns, from any claim whatsoever that arises or may hereafter arise on account of any first aid treatment or service rendered on connection with the Participant's participation in and attendance at or any veterinary treatment rendered to Horse or Pony in connection with the Horse or Pony's engagement in activities in the Event at the Venue.

3. **ASSUMPTION OF RISK.** The Participant acknowledges and agrees that participation in the Event sponsored by Molly Hill Farm, LLC at the Venue may include activities that may be hazardous to the Participant, including but not limited to, riding or walking in close proximity to Horses and Ponies. The Participant acknowledges and agrees that participation in the Event sponsored by Molly Hill Farm, LLC at the Venue may include activities that may be hazardous to the Horse/Pony. In connection thereto, Participant or Member recognize and understand that attendance at and participation in the event sponsored by Molly Hill Farm, LLC at the Venue may, in some situations, involve inherently dangerous activities and environments. Participant or Member hereby expressly and specifically assumes the risk of injury or harm to Horse/ Pony arising from it's Participation in the Event and release Molly Hill Farm, LLC from all liability for injury, illness, death, property damage to Participant or Horse/ Pony resulting from the Participant's attendance at and/or participation in the Event sponsored by Molly Hill Farm, LLC at the Venue.

4. **OTHER.** Participant or Member expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Maryland, and that this release shall be governed by and interpreted on accordance with the laws of the State of Maryland. Participant or Member agree that in the event that any clause or provision of this release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

Participant or Member has executed this Release as of the day and year first above written.

I agree that if I am a parent or guardian of a junior participant, I consent to the child's participation and agree to all of the above provisions and agree to assume all of the obligations of this Release on the child's behalf.

COVID-19 PARTICIPATION WAIVER

This waiver relates to _____ (the "Participant") and his or her engagement in activities at Molly Hill Farm ("Molly Hill"), operated by Molly Hill Farm, LLC. In consideration of the Participant's engagement in horse activities at Molly Hill, as the undersigned Participant or parent/guardian of a minor Participant, I understand and agree to the terms set forth herein.

In or around March 2020, an outbreak of a serious respiratory disease ("COVID-19") caused by the novel coronavirus arose in the United States. As a result of such outbreak, Governor Hogan declared a state of emergency and catastrophic health emergency to control and prevent the spread of COVID-19 within the State of Maryland. Subsequently, the Governor issued several executive orders intended to protect the public health, safety, and welfare. As of June 10, 2020, in accordance with the Governor's order, while certain facilities may reopen to the public and various educational programs may resume, it is still strongly recommended that all Marylanders continue following the most current guidance from Centers for Disease Control and the Maryland Health Department regarding social distancing, including, without limitation, avoidance of large gatherings and crowded places. The undersigned parties acknowledge that the Governor's administration is hereby authorized to issue new orders and directives requiring individuals to remain indoors or to refrain from congregating, as the Governor and his administration deems necessary to monitor, treat, prevent, reduce the spread of, and suppress COVID-19.

Because Molly Hill provides services to board and care for animals, I acknowledge that its facilities may have remained open and in use by boarders and other individuals throughout the rise of the COVID-19 pandemic, and as a result, I recognize that by participating in the Stable's activities, I or my minor child Participant may be at higher risk of contracting COVID-19.

I, the undersigned Participant or parent/guardian of a minor child Participant, agree that I am personally responsible for my decision to allow myself or my child to visit and participate in Molly Hill activities. I agree to ensure that I and/or my minor child Participant complies with all Molly Hill policies and rules, including but not limited to all safety precautions set forth by the State of Maryland and Molly Hill, as well as posted signage and written or oral instructions given by Molly Hill staff.

By signing this agreement, I affirm, to the best of my knowledge, that I am, and/or my minor child Participant is in good physical condition and health and is physically able to participate in horse activities at Molly Hill. On behalf of myself, and/or as my minor child's parent/guardian, I assume, to the greatest extent permitted by law, all the risks involved in my and/or my child's use of Molly Hill facilities, whether or not such risks are specifically identified herein, and including but not limited to the potential for contracting COVID-19. I understand that if I and/or my minor child fails to abide by the directions given to me/him/her by Molly Hill members or staff during my or my minor child's participation in activities at Molly Hill, my, his or her access to Molly Hill may be limited, at the discretion of Molly Hill staff. I also understand that the Molly Hill or the State of Maryland may stop or suspend activities at Molly Hill at any time, for any reason.

I further acknowledge that due to the unknown factors of transmission of the COVID-19 virus, I, my child, or my family may pose a risk to other individuals who use or work at the Molly Hill facilities. **I, or as my minor child's parent/guardian, I assume all responsibility for ensuring that I and/or my minor child Participant, shall not visit Molly Hill if I exhibit, or he or she exhibits any of the following symptoms:**

**Fever or chills | Cough | Shortness of breath or difficulty breathing | Fatigue | Muscle or body aches | Headache
New loss of taste or smell | Sore throat | Congestion or runny nose | Nausea or vomiting | Diarrhea**

If I, and/or my minor child does exhibit these symptoms, I hereby agree to notify the staff of Molly Hill program immediately.

I hereby release Molly Hill from any and all civil liability, sounding in tort, contract or any other area of civil law relating to any accident, injury, loss or damage occurring in connection with my or my minor child's participation in activities at Molly Hill. I hereby waive any and all of my rights to bring suit against Molly Hill for same, and I will indemnify, defend, and hold harmless Molly Hill from any and all third-party and first-party costs, claims, and liability incurred by Molly Hill which result, directly or indirectly, from my or my minor child's participation in horse activities at Molly Hill, including but not limited to attorney fees and expenses. For purposes of this Waiver, the term "Molly Hill" includes its agents, officers, and employees. I agree that the exclusive venue of any suit against Molly Hill for any reason shall be the courts of Harford County, Maryland and I consent to the jurisdiction of such courts in any action taken against me.

This waiver will be interpreted under the laws of the State of Maryland and will be admissible in any civil action arising out of my or my minor child's participation in activities and use of facilities maintained or used by Molly Hill. If any portion of the waiver is found to be invalid, all other portions of the waiver shall be fully enforced. I have read this document in its entirety, understand its contents, and sign it of my own free will. I can read and understand the English language and have full legal capacity to enter into this waiver.
